### From the desk of MRR Board President John Graifemberg

As stated in the notice of this year's annual members meeting, the format of the meeting will be modified due to the Coronavirus Pandemic. 

#### Has Catch and Release Gone Overboard?

This spring issue of *Montana Outdoors* is about fishing and more than trout, but the article that would interest MRR anglers most is, "Has catch-and-release gone overboard?" by Tom Dickson. He argues that killing a trout now and again may even improve the health of a fishery by allowing increased growth in the population, given that food supply is finite. However, he considers some catch/release essential for sustaining "renowned trout fisheries" (read Madison River).

Dickson did not mention the effect of catch and keep on the average size in the populations. Removing a 20 some inch 5 or 6-year-old trout takes a while to replace, keeping the big ones can lower the average size of a population, and a big one is the goal of most anglers. Slot limits and limits on larger fish existing on the lower river tend to compensate for that problem. However, Dickson points out that large trout may be reaching their end of life, so removing them may ultimately have little effect on population average size.

Then there is the issue of survival of released fish that were played too long, especially in water reaching mid-day temperatures in the high 60s, or deeply hooked. My observation is that mangled jaw bones are not that unusual in Madison fish. Dickson points out that each Madison rainbow trout is caught on average 4.5 times, and 8% of released fish die amounting to 32,000 fish per year.

Nevertheless, population estimates from FW&P's electrofishing at the three-mile stretch upstream from Lyon's Bridge, has shown population estimates from 2000 to 2015 (after recovery from whirling disease) of rainbows 14 inches and larger and browns 15 inches and larger averaging 400 and 550 per mile of stream length, respectively. To me, that's not enough good-size fish to withstand the large and increasing number of anglers without showing significant reduction in average size and/or population abundance even if the limit were even one or two fish per day. (I do not have more recent population estimates, because the fisheries biologist at Ennis who sent me annual reports has retired.)

Dickson's main point though is killing a trout, or a walleye especially, should not be taboo, so long as the population is not overfished. He suggests that MT FWP's regulations take those aspects into account when they set the fishing regulations.

This magazine is published bimonthly by Montana Fish Wildlife and Parks and is generally split between fishing and hunting articles written by biologist and managers. The winter issue is especially great being completely of wildlife pictures. I certainly recommend it.

### **Spaghetti with Clam Sauce**

2 cloves garlic, crushed

2/3 c. olive oil

1 c. bottled clam juice

½ t. salt

Fresh cracked pepper

½ t. oregano

2 cans minced clams

½ c. chopped parsley

½ c. minced green onion tops

1 lb spaghetti or vermicelli, cooked according to pkg. directions

Parmesan cheese

Saute garlic in oil. Add clam juice, salt, pepper and oregano. Simmer 5 minutes.

Add clams with their own juice. Cook uncovered, about 10 minutes, so liquid will reduce.

Mix in parsley and onion. Toss half of sauce with pasta and top with rest of sauce and Parmesan.
